**Dear Members,**



### *Continued Efforts with Telehealth*

Teletherapy remained a significant area of advocacy for TAASLP as we closed out 2020 and as we began 2021. Advocacy efforts have focused on making sure that Tennessee graduate students in Audiology and Speech-Language Pathology were able to utilize teletherapy as a modality to obtain hours for their clinic placements. TAASLP Advocacy also learned more about the ASHA-Interstate Compact by attending a Legislative Summit in October 2020. After attending this summit, TAASLP is even more committed to ensuring that teletherapy is an area of service modality that is secure in Tennessee for Audiologists and Speech-Language Pathologists. Securing teletherapy will not only help improve our abilities to be part of the ASHA-Interstate Compact but it also continues to help professionals deliver much-needed services to their clients and students across the State. As 2021 continues to unfold, TAASLP will be working with our lobbyists and State Legislators toward teletherapy legislation during this upcoming legislative session. The goal of this upcoming legislation will look toward ensuring our current teletherapy rules are in line with the current Tennessee telehealth statute.

### *School SLP Legislation is Being Re-Introduced!*

HB0023 is being reintroduced in the House of Representatives by Representative Scott Cepicky. This legislation asks the Tennessee Department of Education to find out information about the needs of school-based SLPs in Tennessee school districts and whether the districts are staffed sufficiently across the State, initially through the use of a survey. This legislation was brought up in the 2020 session; however, it was dropped due to Covid. Finding out this information will provide valuable information as TAASLP works toward caseload and workload support for school-based SLPs in Tennessee.

## TAASLP Honors

### Dr. Les Hutchinson with Distinguished Service Award

TAASLP has the honor of recognizing Les Hutchinson, PhD as the 2020 recipient of the **TAASLP Distinguished Service Award**. Dr. Hutchinson was nominated by TAASLP Members, Andrea Green AuD, Randi Yontz AuD and Whitney Manuel AuD for his outstanding work with HEAR Nashville, a non-profit founded by Dr. Hutchinson in 2010 with a vision to provide financial assistance to low income adults in middle Tennessee who need hearing aids.

After completing his PhD in Clinical Psychology at Vanderbilt University in 1975, Dr. Hutchinson dedicated his career to supporting the improved health of individuals while working as Chief Psychologist for the Tennessee Department of Correction, Executive Director of Luton Community Mental Health Center, Director of Wellness and Health Promotion at Vanderbilt University Medical Center and CEO at the League for the Deaf and Hard of Hearing in Nashville until his retirement in 2007.

In the twilight of his career, Dr. Hutchinson stated *"I became increasingly aware of how difficult it was for low income adults in*

*particular to obtain hearing aids which could have helped them significantly with education, employment, social and family relationships due to the fact that neither government nor private insurance provided enough coverage for hearing aids."* In his retirement he embarked on his mission to use his 35+years experience in health and wellness along with relationships with agencies across Tennessee to start the non-profit, HEAR Nashville.

HEAR Nashville stands for "Hearing Education and Assistance Resource" and is a collaboration of the Sertoma Club of Nashville, Vanderbilt Bill Wilkerson Center, the Audiology section of the Department of Speech Pathology at Tennessee State University, Bridges, and the Nashville chapter of the Hearing Loss Association of America. HEAR Nashville not only provides financial assistance for individuals to obtain hearing aids, but also provides community education about hearing and hearing loss through presentations, health fairs, and publications. HEAR Nashville also depends on grants, donations and gifts from local foundations and is a completely volunteer-run organization that, in 10 years, has served over 1100 individuals throughout middle Tennessee on the path to improved hearing.

In the nomination process, Dr. Hutchinson's colleagues commented about his dedication and passion for helping others, "I could not think of a more deserving individual for this award. Dr. Hutchinson had dedicated his life to helping those with hearing loss and it is my privilege to volunteer beside him. His work has directly impacted so many patients. "

TAASLP applauds you, Dr. Hutchinson, on the impact you have made over your career to improve the quality of life and communication for so many individuals in Tennessee.

# 2021 ASHA Public Policy Agenda

## SCHOOL PRIORITIES

- ❖ **Advocate** for public policies that promote equitable access to school-based audiology and speech-language pathology services, multiple models of service delivery, and telepractice technology.
- ❖ **Advocate** for public policies that support school-based audiologists and speech-language pathologists in acquiring materials, technology, and training to deliver services effectively and equitably across multiple models of service delivery.
- ❖ **Advocate** that school-based audiologists and speech-language pathologists receive competitive wages that align with other licensed professionals who have comparable academic preparation, clinical training, and/or certification.
- ❖ **Advocate** for public policies that promote manageable workloads to optimize student outcomes, and support both clinical excellence and ethical practice.
- ❖ **Advocate** for effective funding to support the assessment, treatment, and management of speech, language, cognitive, hearing, balance, voice, and feeding/swallowing disorders.
